A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, AUTHORIZING AND DIRECTING THE DIRECTOR OF FINANCE AND/OR CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO SEEK AND OBTAIN PROPOSALS FOR THE BORROWING OF A 2018 TAX ANTICIPATION NOTE IN AN AMOUNT NOT TO EXCEED \$1,500,000 AND FOR CLOSING NO LATER THAN DECEMBER 31, 2017.

WHEREAS, the City of Johnstown ("Local Government Unit") expects to receive current revenues, as yet uncollected, during the first two quarters of fiscal year ending December 31, 2018; and

WHEREAS, the Local Government Unit will have inadequate funds for operating expenditures during the first two quarters of 2018, based on funds flow analysis of tax receipts; and

WHEREAS, the Local Government Unit has determined that it is necessary to borrow for the purpose of meeting expenses during the first two quarters of 2018 by issuing a note, to be repaid from anticipated revenues.

NOW, THEREFORE, BE IT RESOLVED, by the City Council (hereafter the "Governing Body") of the Local Government Unit, directs and authorizes the Director of Finance and/or City Manager to seek proposals and/or written quotes for the borrowing of funds through a Tax Anticipation Note not to exceed \$1,500,000 and for closing no later than December 31, 2017, subject to the final adoption of the 2017 City of Johnstown operating budget by City Council.

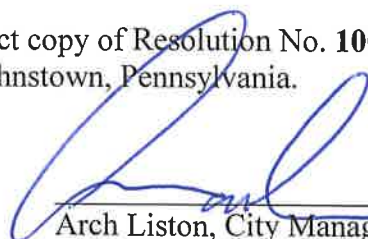

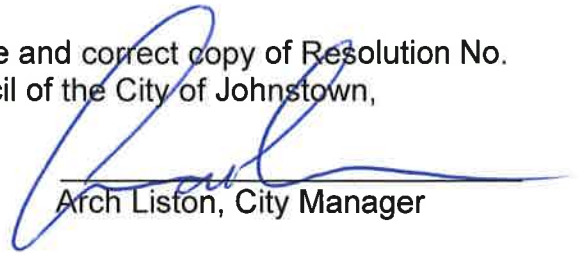

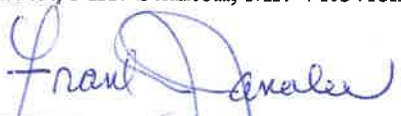

A RESOLUTION OF CITY COUNCIL, OF THE CITY OF JOHNSTOWN, PENNSYLVANIA AUTHORIZING THE CITY MANAGER AND CITY SOLICITOR TO EXECUTE THE ATTACHED SETTLEMENT AGREEMENT WITH GAPVAX, INC. TO RESOLVE A TAX ASSESSMENT APPEAL REGARDING PROPERTY LOCATED AT 575 INDUSTRIAL AVENUE JOHNSTOWN, PA 15902, AND TO TAKE ANY/ALL ACTIONS NECESSARY TO EFFECTUATE SAME.

WHEREAS, GAPVAX, Inc., filed a Tax Assessment Appeal in the Court of Common Pleas of Cambria County at Docket No. 2017-1837, challenging the estimated fair market value of \$6,359,514.00 assigned to its property located at 575 Industrial Avenue Johnstown, PA 15902: and

WHEREAS, after the parties exchanged appraisals, the parties, to include the City, the Cambria County Tax Assessment Office and the Greater Johnstown School District have engaged in settlement discussions with GapVax and identified a value on the property of \$2,400,000 a reasonable value upon which to resolve the matter; and

WHEREAS, prior to the re-assessment of the property, the City received \$8,589.74 a year in Real Estate Taxes for the property, and with the new agreed upon value of \$2,400,000, the City will receive an estimated amount of \$30,489.00, which constitutes an increase of \$21,899.26 in tax proceeds while also avoiding the burden, expense, and uncertainty of further litigation; and

WHEREAS, the proposed settlement agreement is attached hereto as Attachment A;

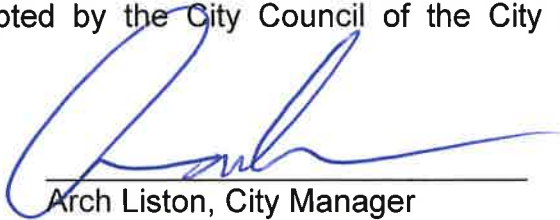

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF JOHSTOWN,
PENNSYLVANIA, AUTHORIZING THE ALLOCATION OF 2017 FUNDS FROM
THE GENERAL MUNICIPAL PENSION SYSTEM STATE AID PROGRAM

WHEREAS, Act 205 of 1984 established the General Municipal Pension System State Aid Program, to provide annual allocations to the municipalities of the Commonwealth beginning in October, 1985; and

WHEREAS, this State Aid is funded by the entire proceeds of Foreign Casualty Insurance Premium Tax and a portion of the State's Fire Insurance Premium Tax; and

WHEREAS, Act 205 replaced the annual allocation of Foreign Casualty Insurance Premium Tax Proceeds and Foreign Fire Insurance Tax Proceeds to offset police pension and paid fire pension costs, respectively; and

WHEREAS, the 2017 General Municipal Pension System State Aid for Johnstown, in the amount of \$936,003.69 has been forwarded to the Trustee by the Department of the Auditor General; and

WHEREAS, under Act 205, the governing body of the municipality determines, during the period September 23, 2017 to October 22, 2017, the allocation of the 2017 General Municipal Pension System State Aid to the City of Johnstown's Pension Funds – Police, Fire, Sewage, and the Officers' and Employees' (Non-Uniformed).

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Johnstown, Pennsylvania, hereby allocates the 2017 General Municipal Pension System State Aid Funds as follows:

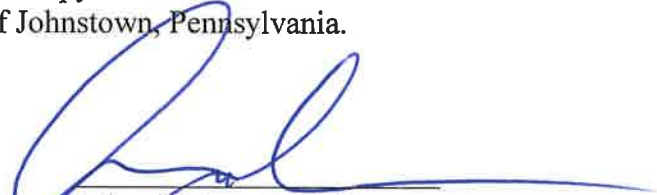

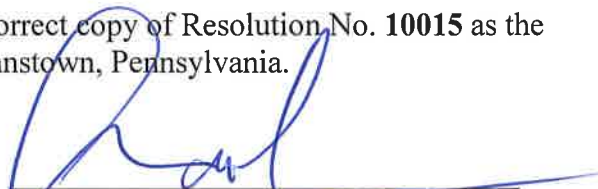

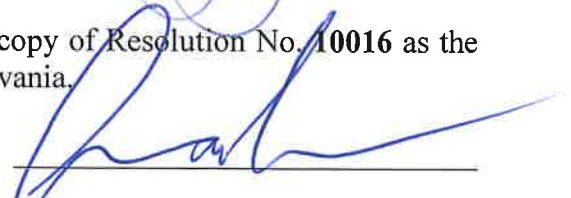

RESOLUTION NO. 9995 (as amended)

A RESOLUTION OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, COMMONWEALTH OF PENNSYLVANIA APPROVING TRANSFER OF LIQUOR LICENSE NUMBER R-8203 INTO THE CITY OF JOHNSTOWN FROM PORTAGE BOROUGH.

WHEREAS, Act 141 of 2000 (the Act), which amends the Commonwealth's Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provide for in section 461 of the Liquor Code, if sales of liquor and malt beverages are legal in the municipality receiving the license; and

WHEREAS, the receiving municipality must issue a resolution approving the transfer of the liquor license outside the municipality to inside the municipality, and

~~WHEREAS, amendments to the Liquor Code stipulate that, prior to the adoption of a resolution by the receiving municipality, at least one hearing must be held by the PLCB for the purpose of permitting interested parties to state their concerns regarding the transfer of a liquor license into the receiving municipality; and~~

WHEREAS, an application for transfer filed under the Act for purposes of pursuing such matters must contain a copy of the Resolution adopted by the municipality approving the transfer of the liquor license into the municipality, and

WHEREAS, the proposed liquor license transfer was included on the Public Agenda for the September 13, 2017 City Council meeting, an opportunity for hearing of the public and acceptance of public comment on said Resolution was afforded at the beginning of said meeting, and no objections or other commentary was offered with respect to the proposed liquor license transfer; and

WHEREAS, the City of Johnstown finds that a transfer of a liquor license into the City of Johnstown by Wolf's Den Properties, LLC will not adversely affect the welfare, health, peace and morals of the municipality or its residents;

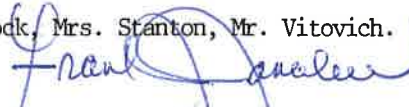

A RESOLUTION OF THE CITY COUNCIL, OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA, AUTHORIZING THE CITY SOLICITOR AND CITY MANAGER TO DEVELOP AND EXECUTE, RESPECTIVELY, AN AGREEMENT FOR THE PURCHASE OF CERTAIN PROPERTY REFERENCED HEREIN AS 722 BARCLAY STREET, FROM FIRST SUMMIT BANK IN AN AMOUNT NOT TO EXCEED \$6,000.00, AND FURTHER AUTHORIZING THE CITY MANAGER TO UTILIZE INNER CITY SEWER FUNDS FOR SAID PURCHASE AND TO EXECUTE ALL NECESSARY DOCUMENTS TO EFFECTUATE SAME, RESPECTIVELY.

WHEREAS, the City of Johnstown has undertaken a project involving the construction and rehabilitation of its inner city sewer system (hereinafter "City Sewer Rehabilitation Project"); and

WHEREAS, in connection with work to be performed on the City Sewer Rehabilitation Project the City has encountered a vacant property at Tax Map No. 76-008-302.00, Dist. No. 76, Control No. 815, and known as 722 Barclay Street, Johnstown, Pennsylvania for which the sewer work to be performed by the City will cause the City to incur construction cost estimated at \$50,000, to ultimately be paid out of the City's PENNVEST loan funding and local sewer funds; and

WHEREAS, the City will incur significant savings and avoid the incurrence of further indebtedness for its sewer construction project by purchasing and ultimately demolishing the property in lieu of completing the City Sewer Rehabilitation Project work for same; and

WHEREAS, the property is currently vacant, owned by First Summit Bank, and confirmed as being available for sale for an amount not to exceed \$6,000.00, inclusive of its adjoining lot at Tax Map Parcel No. 76-008-302.00, Dist. No. 76, Control No. 864; and

WHEREAS, the City imposes monthly sewer rental charges for the use, whether or direct or indirect of the City's sewage collection system; and

WHEREAS, the City Council hereby determines that the expense of acquiring the property, arises in connection with the City Sewer Rehabilitation Project and ultimately reduces costs pertaining to that project and avoid the incurrence of a certain amount of further indebtedness for the sewer construction costs that would otherwise be required; and

WHEREAS, any agreement developed to purchase the property shall be made contingent upon receipt of satisfactory title search results and confirmation of clear title to the property;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Johnstown, that the City of Johnstown hereby authorizes the acquisition and purchase of a vacant property and adjoining lot located at 722 Barclay Street, Johnstown, PA from First Summit Bank, in an amount not to exceed \$6,000.00, contingent upon a satisfactory title search, and confirmation of clear title; and further authorizes the City Solicitor and City Manager to develop and execute, respectively,

an Agreement of Sale and authorizes the City Manager to utilize inner city sewer funds, take any/all other actions necessary, to effectuate same.

A RESOLUTION OF THE CITY COUNCIL, OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA, AUTHORIZING THE CITY MANAGER SIGN ALL DOCUMENTS NECESSARY TO IMPLEMENT AMENDMENTS TO THE INVESTMENT MANAGEMENT AND AGREEMENT OF TRUST BY AND BETWEEN THE CITY OF JOHNSTOWN COMBINED PENSION PLAN AND STATE STREET GLOBAL ADVISERS TRUST COMPANY TO IMPLEMENT AN UPDATED FEE SCHEDULE AND CERTAIN OTHER TERMS AND CONDITIONS SPECIFIED HEREIN.

WHEREAS, the City of Johnstown is party to an investment management agreement originally dated September 17, 2007 and with State Street Bank & Trust Company and later assigned to State Street Global Advisors Trust Company on April 1, 2017; and

WHEREAS, the City of Johnstown is likewise party to an agreement dated December 14, 2007 between the City of Johnstown Combined Pension Plan and State Street Global Advisors Trust Company in its capacity as trustee, following its appointment as successor trustee of the grantor trust by State Street Bank & Trust Company; and

WHEREAS, State Street Global Advisors have recommended certain amendments to the aforementioned agreements in order to implement updated investment guidelines, updated language addressing obligations under federal law to disclose the identities of clients opening accounts and updated fee schedule providing for a flat fee of .45% intended to be more advantageous for the City of Johnstown; and

WHEREAS, the effective date of the new fee schedule will and is intended to be retroactive to October 1, 2017, I.e., the first day of the current quarter in which the agreements are executed, if the attached agreements implementing amendments are executed prior to December 31, 2017; and

WHEREAS, the updated investment guidelines will be given an effective date identified as one week after the date on which the agreements are signed by all parties;

WHEREAS, the City of Johnstown Pension Board has reviewed and approved the proposed agreements, which are attached hereto as Attachment A ("Investment Management Agreement Amendment") and Attachment B ("Trust Agreement Amendment");

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Johnstown, that the City Council of the City of Johnstown authorizes the City Manager to sign the attached agreements implementing amendments to the Investment Management Agreement and the Agreement of Trust, with a retroactive date of November 8, 2017

applicable to each amending agreement, and implementing additional effective dates for the fee schedule and investment guidelines as provided herein.
