AN ORDINANCE ADOPTING THE SEVENTH AMENDED MUNICIPAL RECOVERY PLAN OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, PURSUANT TO THE MUNICIPALITIES FINANCIAL RECOVERY ACT (ACT 47 OF 1987) AS AMENDED

WHEREAS, on May 26, 1993, the City Council of Johnstown enacted Ordinance No. 4644 approving the adoption and implementation of the Municipal Recovery Plan for the City of Johnstown pursuant to Act 47 of 1987 as amended; and

WHEREAS, on February 26, 1997, the City Council of the City of Johnstown adopted its First Amended Municipal Recovery Plan pursuant to act 47 of 1987 as amended; and

WHEREAS, on January 3, 2000, the City Council of the City of Johnstown adopted its Second Amended Municipal Recovery Plan pursuant to Act 47 of 1987 as amended; and

WHEREAS, on December 30, 2002, the City Council of the City of Johnstown adopted its Third Amended Municipal Recovery Plan pursuant to Act 47 of 1987 as amended; and

WHEREAS, on December 12, 2007, the City Council of the City of Johnstown adopted its Fourth Amended Municipal Recovery Plan pursuant to Act 47 of 1987 as amended; and

WHEREAS, on December 30, 2010, the City Council of the City of Johnstown adopted its Fifth Amended Municipal Recovery Plan pursuant to Act 47 of 1987 as amended; and

WHEREAS, on October 28, 2013, the City Council of the City of Johnstown adopted its Sixth Amended Municipal Recovery Plan pursuant to Act 47 of 1987 as amended; and

WHEREAS, although substantial progress has been made in implementing the Recovery Plan, based on the recommendation of the Recovery Plan Coordinator, City Council has concluded that not all conditions leading to the City's financial distress have been alleviated and that the City should continue to operate under a Seventh Amended Recovery Plan;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the City Council of the City of Johnstown, Pennsylvania, and it is hereby enacted and ordained by the authority of the same that follows:

Section 1. The City Council of the City of Johnstown, Pennsylvania, hereby approves the adoption and implementation of the Seventh Amended Recovery Plan of the City of Johnstown, as presented by the Recovery Team Coordinator and dated July 12, 2017, including subsequent amendments thereto, if any, pursuant to Act 47 of 1987, as amended.

Section 2. The City Manager and the City Solicitor are hereby authorized and directed to prepare for adoption any necessary ordinances or resolutions and revisions to ordinances or resolutions to implement the Seventh Amended Recovery Plan.
