Liberoni, Inc. is the apparent low bidder for Contract 2017-01, 8th Ward Sanitary/Storm Sewer Separation Project, with a Total Base Bid with Material Alternate, Additive Alternate Bid 1 with Material Alternate, Additive Alternate Bid 2 with Material Alternate, and Additive Alternate Bid 3 with Material Alternate for a total of \$5,292,950.00.





RESOLUTION NO. 9884

A RESOLUTION of the City Council of the City of Johnstown, Pennsylvania authorizing the solicitation for proposals for planning consulting services for a period of three years from October 15, 2016 through October 14, 2019.

WHEREAS, the City receives annual Entitlement Grants from the U.S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant Program (CDBG), and the HOME Investment Partnership Program (HOME); and

WHEREAS, the City is undertaking various projects and activities such as housing, community development, economic development, redevelopment, planning and urban design, as well as the preparation of its Annual Action Plans, annual Environmental Review Records (ERR), yearly Consolidated Annual Performance Evaluation Reports (CAPERS), and other required plans and policies by HUD; and

WHEREAS, the City desires to hire a consulting firm to assist in the preparation of these plans and project activities; and

WHEREAS, the City will abide by the provisions of the "Common Rule" (24 CFR Part 85.36) which establishes the standards for the procurement of property and services involving the expenditure of federal funds.

SECTION 1. The City hereby authorizes the advertising for proposals for planning consulting services for the City's community and economic development, housing, and other community development programs.


