# JOHNSTOWN CITY COUNCIL MINUTES

Wednesday, February 8, 2017

City Council met in a stated session for the general transaction of business. Mayor Frank Janakovic called the meeting to order at 6:10 p.m. Council had a moment of silence for Dorothy Haselrig Thomas who recently passed.

Arch Liston, City Manager, offered the invocation, and the Pledge of Allegiance was recited.

An Executive Session was noted to be held prior to the commencement of the meeting.

The following members of Council were present for roll call:

City Manager Arch Liston and Elizabeth Benjamin, Solicitor, were also present.

#### APPROVAL OF MINUTES

Mr. Vitovich made a motion to approve the December 29, 2016 and January 11, 2017 Regular Meeting Minutes. The motion was seconded by Mrs. Mock and passed by the following vote:

## PROCLAMATIONS, AWARDS, HONORS, RESOLUTIONS OF RECOGNITION

- Mrs. Stanton requested that a proclamation be issued regarding Multiple Sclerosis Awareness Week, March 5 through March 11, 2017.
- Mayor Janakovic was approached by the Guidance Counselor Association, PA

  Department of Education requesting a proclamation for all of the guidance counselors throughout the area.
- Mr. Williams made a motion to approve both proclamations. The motion was seconded by Mr. Vitovich and passed by the following vote:

## PUBLIC COMMENT ON AGENDA ITEMS ONLY

John DeBartola, 1197 Bedford Street, Johnstown, and President of the Keystone Alliance Gay Life Newsletter, addressed Council with regard to hate crimes and nondiscrimination ordinances. He stated the City will join 38 other municipalities in Pennsylvania if the two ordinances were adopted, He suggested that the ordinances include language for ethnic intimidation. Mr. DeBartola noted the passing of the ordinances was the first step in the right direction. He commended Council for starting the process of creating the ordinances and hoped the ordinances would be passed.

- Joseph Warhul, 44 Clover Street, Johnstown, addressed Council with regard to Bill No. 50, which addresses the powers and duties of Council. He discussed an appointee to the Housing Authority who was incarcerated for two weeks due to a violation of probation for a second DUI. Mr. Warhul suggested that the man be removed from his position on the Housing Authority.
- Ms. Benjamin explained there is power vested in Council via the Home Rule Charter and Administrative Code addressing the ability to appoint and remove members of authorities, boards and commissions. She noted however there are other statutes that provide alternative measures. She noted that the matter may be researched further at the request of Council.
- Mr. Williams made a motion that the City Solicitor contact the Court of Common Pleas to determine the facts relative to the matter and report back to Council. Mayor Janakovic suggested that the City Solicitor review the Housing Authority rules with HUD with regard to the matter. The motion was seconded by Mrs. Mock and passed by the following vote:

Mr. Vitovich abstained from voting on the motion.

Dr. CatherineAnne McCloskey-Ross, 500 Broad Street, Johnstown, addressed Council as a representative of the City's transgender support group. She discussed the nondiscrimination ordinance. She noted that anyone objecting to this ordinance "is objecting to the way she exists".

## REPORT BY CITY MANAGER

- Arch Liston, City Manager, reported on vacancies in the police department and the need to diversify the workforce. He stated Civil Service tests will be given March 18, 2017. He encouraged women and minorities to sign up to take the test.
- Mr. Liston noted that parking tickets will be collected more aggressively as there were a substantial number of unpaid parking tickets.
- He noted a deed search with regard to the golf course. There are no restrictions with regard to monetizing the asset. He asked Council for their authorization to continue with the title search process for a possible future sale.
- He discussed the replacement of the carpeting at the Pasquerilla Conference Center.

  Mr. Liston stated a roof leak at the center makes replacing the carpeting at this point "kind of senseless" until the roof is repaired. He stated a warranty still exists on the roof, and the company will be contacted with regard to those repairs.
- There was discussion regarding whether an invoice or billing in the amount of \$90,000 had been received. Mr. Williams noted an annual letter from the Pasquerilla Conference Center requesting reimbursement in the amount of \$80,000 for carpeting. Mayor Janakovic had never seen an invoice for work or carpeting purchased in that amount. There was further discussion regarding the matter.
- Ms. Benjamin explained the need to address the roof situation prior to the carpeting matter. Mr. Williams requested an answer with regard to money that is owed. He commented, the "obligation is due".
- Mrs. Mock made a motion to invite Mr. Barletta to a Workshop before the next Council meeting for further discussion regarding the matter.
- Mrs. Stanton suggested a letter be sent to Mr. Barletta stating the carpeting will not be replaced until the roof leak is repaired. The letter should request that Mr. Barletta obtain three estimates for the price of the carpeting at the Convention Center. She noted a resolution could be prepared at the next Council meeting if the matter is confirmed.
- Mayor Janakovic responded that Mr. Barletta had already agreed to the roof repair before replacing the carpeting.

- Mrs. Stanton made a motion to obtain three carpeting estimates. The motion was seconded by Mrs. Mock.
- The City Manager reiterated that the roof repair must first be resolved, and then the vendors will be contacted to address the carpeting matter.
- Mr. Williams noted, "There is nowhere in any submissions that Crown is required other than to make the request and wait 20 days before they assume it's approved, that they have to submit an invoice to the City for payment."
- Ms. Benjamin explained that the carpeting at the Convention Center was a capital expenditure and Crown submits a request for a certain amount to be included in the budget to allow for that going forward. She further explained that the parties may agree to obtain estimates.
- The City Manager noted that bids for 22 HUD properties will be received for demolition in April.
- Mr. Liston was awaiting the final report from the auditor with regard to the District Attorney's Office drug fund monies.
- He discussed the first resolution on the agenda concerning the SAFER grant for firefighters. Mr. Liston requested the resolution be withdrawn.
- Mrs. Mock made a motion authorizing the City Manager to commence the title search process for the golf course. The motion was seconded by Mr. Vizza and passed by the following vote:

Andrea Ryan, 190 Derby Street, Johnstown, addressed Council with her concerns regarding the ordinances for final read on the agenda. She noted the ordinances "seem to represent a trend of relaxing the codes currently on the books that would accommodate the offenders of those codes." Ms. Ryan suggested the accountability by property owners and the codes department. She urged Council to consider applying to Cambria County for Act 152 funds, inquiring of the codes department for reasons the codes are not being enforced, amending ordinances related to blight and rejecting Resolution 7A by requiring owners to pay and not the City's taxpayers.

Mrs. Stanton agreed with the comments made by Ms. Ryan.

- Mayor Janakovic explained that Commissioner Chernisky passed Act 152, a \$15 fee on transfers and purchases only used for demolition. He stated the decision on the fair allocation of those monies across the county was yet to be determined.
- There was a discussion regarding the cost of the demolition of the Conrad Building.

  The Mayor noted the cost to demolish roughly 1,200 properties throughout the City could cost as much as \$9.6 million.

#### REPORT BY THE MAYOR

- Frank Janakovic, Mayor, reported on attending, along with Mrs. Mock and Mr. Vizza, a Martin Luther King musical play at Johnstown High School on Sunday, January 15, 2017, presented by the Johnstown Community Gospel Choir, NAACP Youth Council representing five difference school districts, the Youth Christ Centered Community Church, Greater Johnstown Interact club and AmeriCorps. A proclamation was presented.
- The Mayor and Mr. Vizza attended a fundraiser for Dorothy Thomas, who recently passed away. He commended the Greater Johnstown School District and East Side Elementary for honoring this person who had done so much for the community.
- Mr. Janakovic also noted his attendance, along with Mr. Vitovich and Mrs. Mock, at the unity rally organized by NAACP, which was held in Central Park on Monday, January 16, 2017 at noon.
- Mayor Janakovic also reported on attending the monthly meetings of the Chamber of Commerce, Discover Downtown, and Vision 2025. He noted 22 different work groups and over 200 people participating in the groups for Vision 2025.
- The Mayor met with the City Manager, Ms. Daly and the Army Corps of Engineers with regard to a \$250,000 grant to review the waterways.
- Congratulations were offered to Gary Poborsky of GAP VAX for creating 50 to 75 new jobs.
- Mayor Janakovic noted approximately 50 people attended a roundtable discussion with local mayors, supervisors and councilmen to discuss a collaboration, cooperation, sharing resources, and grants among the City with local boroughs and townships around the City. He noted the County Commissioners, Judge

Krumenacker, Michael Foreman from DCED, Deb Grass from Act 47, Melissa Komar from JRA, Wally Burlack from Vision, as well as City Manager Arch Liston were also in attendance. Representatives from Conemaugh Township, Brownstown, Daisytown Borough, East Conemaugh Borough, East Taylor, Ferndale, Franklin, Geistown, Lorain, Richland, Southmont, Westmont, and West Taylor were also in attendance.

- Mr. Williams inquired as to the status of Resolution 9917 concerning municipal consolidation.
- Mayor Janakovic explained "getting people to the table is the first step" regarding discussions of consolidation.
- Ms. Benjamin could not speak to the meeting as she was not in attendance. She noted the Mayor reached out to the municipalities and organized the meeting. There was further discussion regarding the matter. A copy of Resolution 9917 was distributed for review.
- Ms. Benjamin stated a letter inviting open and general discussion regarding consolidation could be sent. Mayor Janakovic noted the meeting was "simply a discussion" and "50 people were willing to work with our City".
- Mr. Williams wanted the terms of the resolution fulfilled. Ms. Benjamin will follow up on the matter and offer a report at the next meeting.

#### REPORT BY THE CITY SOLICITOR

The City Solicitor reminded all to not speak over one another.

- Ms. Benjamin referenced a letter from Mr. Williams and Mrs. Stanton with regard to Bill No. 48 of 2016, the lateral resale ordinance. She summarized the bill, which allows for a change in compliance, extends the amount of time to 180 days, and allows an additional period of 365 days for homeowners to comply with the pressure testing and remediation requirements. Ms. Benjamin contacted DEP with regard to getting their opinion on the proposed change and received a response confirming that DEP was agreeable to the initial 180-day period but did not provide any further comment on the 365 day period.
- Mayor Janakovic noted Council's vote was taken based on the opinion given by Renee Daly and her conversation with DEP.

Ms. Benjamin explained a discussion concerning the best way of dealing with the problem, which pertains primarily to the phases of the sewer project and the homeowners being required to engage in remediation work within this period of time where the actual installation of the sewer system might not be occurring for a year or so after. She noted a possible amendment to Bill No. 48 would be to provide for a period of 90 days following the point at which the construction project reaches the neighborhood as that is the primary issue. She stated that DEP was again amenable to that change.

She referred to a motion in the packet to amend Bill No. 48, which provides for a temporary certificate of compliance to be effective for 180 days and the City Manager and ordinance compliance officer will have the option to extend this period for up to 90 days after the City had completed the installation of the sewer system. Ms. Benjamin noted this is the best solution as approved by DEP.

- Mr. Williams discussed 23 certificates of compliance that were given extensions as he and Mrs. Stanton reviewed, including a property purchased by ACRP on Franklin Street, which was not in accordance with the ordinances.
- Mayor Janakovic commented that ACRP does have a contract for the sewage work and placed money in escrow for the completion of the work. He commented, "There aren't enough contractors to get the work done."

Renee Daly discussed the line on Catherine Street, which was granted an extension.

- Ms. Benjamin discussed a response relating to correspondence being sent to Craig Bachik and the nonprofit group involved with the Conrad Building. She noted the corporation was requesting that Council, the City Manager, and the City codes office that correction measures have begun with regard to the Conrad Building.
- Mr. Liston noted the Codes Department had not started enforcement action against the Conrad Building. Ms. Daly noted that 303Franklin, LP, was selling the property to JBDDC once the project is approved by EDA, which needs proof that all four floors are being rented. Mr. Liston indicated the building will have to be taken down if affirmative steps are not seen through the summer.
- Ms. Benjamin discussed a proposal that was presented relating to the Washington Street Parking Lot. A resolution will be prepared for the parking lot.
- Mrs. Stanton made a motion to have the property assessed. The amount of property tax on the property should be confirmed with the assessment office.

Mrs. Mock made a motion instructing the City Manager to prepare a resolution with regard to the Washington Street Parking Lot. The motion was seconded by Mr. Vitovich and passed by the following vote:

Ms. Benjamin noted the Johnstown Housing Authority responded with possible dates for a meeting.

Mr. Williams made a motion to recess. The motion was seconded by Mrs. Stanton.

### REPORT BY THE CITY ENGINEER

Andy Fedorko, EADS Group, referred Council to his report for further discussion.

- Mrs. Stanton inquired as to a quality assurance check by the City that the flow monitors are working properly.
- Mr. Fedorko stated the meters are checked every time the meters are moved, which is more often than once a year per the manufacturer's requirement. He stated that any meter not functioning correctly would be removed and replaced with another meter.
- Mrs. Stanton inquired as to the Roxbury flow meter. She also inquired as to a state standard with regard to the diameter of the pipes used for the sewer lines.
- Mr. Fedorko explained the size of the diameter is based on flow of the pipe and that the majority of the lines are 8-inch lines. It also depends on the number of homes being served by the line.
- Mrs. Stanton inquired as to the number of neighborhoods the sewage upgrade would be divided into.
- Mr. Fedorko indicated there were around 14 projects. He explained the number of projects did not coincide with the number of communities.

Mrs. Stanton questioned the number of downspouts illegally connected in the Roxbury area. She also had questions regarding the completion of the Hornerstown phase one.

Mrs. Stanton made a motion that the City immediately cease all flow monitoring until all illegal connections are removed from the system, the accuracy of EADS reports can be examined thoroughly, and that flow monitoring be performed again on any neighborhood that received a failing study. The motion was seconded by Mr. Williams and failed by the following vote:

#### ORDINANCES FOR FINAL READ AND ADOPTION:

BILL NO. 48 OF 2016, AN ORDINANCE SPECIFICALLY AMENDING ORDINANCE NO. 5166 PASSED FINALLY JANUARY 28, 2015, AND AS AMENDED IN ORDINANCE 5179 PASSED FINALLY AUGUST 12, 2015, AND KNOWN AS THE "LATERAL RESALE ORDINANCE" TO REVISE AND FURTHER ESTABLISH VALIDITY PERIODS FOR TEMPORARY CERTIFICATES OF COMPLIANCE ISSUED AND TO ADDRESS ADDITIONAL MATTERS PERTAINING TO SAID TIME PERIODS.

Mr. Williams made a motion to approve the ordinance. The motion was seconded by Mrs. Mock.

Mrs. Stanton made a motion to amend the ordinance to remove the guideline that if a temporary certificate was issued prior to December 2016 a new one can be requested. The motion was seconded by Mr. Williams and failed by the following vote:

Mayor Janakovic abstained from voting on the motion.

Mrs. Stanton made a motion to amend the ordinance to remove the wording, because of the limited number of contractors. The motion was seconded by Mr. Williams.

There was further discussion regarding the ordinance.

Mrs. Stanton noted the reason for amending the ordinance was due to the City "not making it to the neighborhood".

There was further discussion regarding the matter.

Mrs. Mock called for the question.

The motion failed by the following vote:

Ms. Benjamin requested, as previously discussed in her Solicitor's report, a motion to amend Bill No. 1 of 2017, to include additional amendments to Codified

Ordinance Chapter 14. Motion to amend Bill No. 48 of 2016 to provide the changes to the temporary time compliance period proposed in Section 10 in order to allow for time to be granted in accordance with the time installation had been completed for the property owner to that address as shown in the revised amended version of Bill No. 48.

Mrs. Mock made a motion to approve the amendment. The motion was seconded by Mr. Vitovich.

Ms. Benjamin further explained the amended bill would provide for the basic temporary compliance of 180 days and provide for an option for the City Manager and ordinance compliance officer to extend this period up to 90 days from the point which the City had completed installation of the sewer system in that neighborhood.

The motion to amend passed by the following vote:

Mayor Janakovic abstained from voting on the motion.

Mr. Williams made a motion to vote on Bill No. 48 as amended. The motion was seconded by Mrs. Mock.

Mr. Williams noted his support of the 90 days but he would not vote for the final passage based on the amendments of Mrs. Stanton. He commented that those in violation should not be given additional time.

BILL NO. 1 OF 2017, AN ORDINANCE AMENDING CODIFIED ORDINANCE CHAPTER 1480; TITLED VACANT STRUCTURES SUBSECTION 1480.02 GENERAL REQUIREMENTS (3) AND 1480.03 TITLED: REGISTRATION OF STRUCTURES; INSPECTIONS; ABATEMENT OF NUISANCES.

Ms. Benjamin explained the amendment to the bill related to the definition of a vacant structure and intended to close a loophole present in the current version of the ordinance that allows owners of properties to debate their requirement of paying the revolving fee by listing the property for sale. This language

would amend the ordinance to provide that in order to be excluded from the definition, the property must be listed for sale and have one active utility working as well. This will improve the ordinance for giving exceptions for a lack of vacancy and the owner attempting to sell versus an actual vacant structure not being appropriately addressed. Ms. Benjamin noted the proposed change would delete the four consecutive months.

It was noted payments were \$100 minimum per month for seven months. There was further discussion regarding the vacant ordinance.

Mr. Williams made a motion to amend Bill No. 1 of 2017 to include the additional amendments. The motion was seconded by Mrs. Mock and passed by the following vote:

Mrs. Stanton suggested a motion to amend to remove the paragraph with regard to giving the code enforcement officer the option to extend the period determined necessary by extenuating circumstances, determined at the officer's discretion and in no event to exceed any period longer than 60 days unless granted by the City Manager.

Mr. Williams made a motion to amend. The motion was seconded by Mrs. Stanton.

Mr. Williams commented on an incident where the codes officer granted extensions at his discretion. He noted the adopted ordinances "should be enforced and required to be enforced". There was further discussion regarding the matter.

BILL NO. 51 OF 2016, AN ORDINANCE BY COUNCIL OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA, PLACING ON THE MAY 16, 2017 PRIMARY ELECTION BALLOT OF THE CITY OF JOHNSTOWN THE VOTER REFERENDUM QUESTION FOR CONSIDERATION BY THE CITY OF JOHNSTOWN ELECTORATE TO AMEND THE HOME RULE CHARTER TO REDUCE THE NUMBER OF ELECTED COUNCILMEMBERS FROM SIX (6) COUNCIL PERSONS AND ONE (1) MAYOR TO FOUR (4) COUNCIL PERSONS AND ONE (1) MAYOR EFFECTIVE JANUARY 1, 2018 (Tabled December 29, 2016).

An order issued by that Commission for relief may be enforced by the complainant, the City Solicitor or the Commission at the Court of Common Pleas and can impose a general offense penalty in the form of a fine.

She further explained that a complaint filed with the local Commission could be pursued to the point of an order for relief enforced by the Court of Common Pleas and fine imposed.

There was further discussion regarding the matter.

- Mrs. Stanton commented that Bill Nos. 5 and 6 reflect HB 177 and SB 974 and inquired as to why the Senate and House had not passed the bills. She commented that Bill No. 5 as written provided for any protection for religious entities, which she felt would violate the Freedom of Religion. Mayor Janakovic stated the bill prohibits discrimination because of race, color, religion, ancestry, sex and national origin.
- Ms. Benjamin read into the record the remainder of the ordinance with regard to religious denominations, institutions or organization or any education organization offered by a religious organization.
