AN ORDINANCE TO PARTIALLY VACATE POPPY ALLEY FROM 143 LORAIN STREET TOWARDS CROYLE STREET TO THE END OF POPPY ALLEY IN JOHNSTOWN, PENNSYLVANIA, AS A PUBLIC THOROUGHFARE.

WHEREAS, the property owners abutting on 143 Loraine Street towards Croyle Street to the end of Poppy Alley in the 8th Ward of the City of Johnstown, have petitioned the City Council of the City of Johnstown to partially vacate Poppy Alley; and

WHEREAS, there are no existing utilities within Poppy Alley; and

WHEREAS, the property owner would maintain right-of-ways for the access to said utilities; and

WHEREAS, the vacation of Poppy Alley from 143 Loraine Street towards Croyle Street to the end of Poppy Alley would not be adverse to the best interest of the public welfare of the City of Johnstown, Pennsylvania.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the City Council of the City of Johnstown, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1. That Poppy Alley from 143 Loraine Street towards Croyle Street to the end of Poppy Alley in the 8th Ward of the City of Johnstown is hereby vacated as a public thoroughfare.

SECTION 2. That the City of Johnstown is not liable for any utility or sewer relocation cost or any reuse cost incurred by the property owner.

SECTION 3. All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed insofar as they conflict herewith.

SECTION 4. This ordinance shall become effective upon final Passage.

AN ORDINANCE

FURTHER AMENDING ORDINANCE NO. 3411, PASSED FINALLY IN COUNCIL, JUNE 7, 1960, ENTITLED, "AN ORDINANCE ESTABLISHING THE LOOP SYSTEM AND DESIGNATING CERTAIN STREETS AS ONE-WAY STREETS, AS AMENDED BY ORDINANCE NO. 3469, PASSED FINALLY APRIL 18, 1961 AND BY ORDINANCE NO. 3518, PASSED FINALLY APRIL 3, 1962, BY DELETING FROM THE ORDINANCE BAUMER STREET.

BE IT ENACTED AND ORDAINED, by the City Council of the City of Johnstown, Pennsylvania, and it is hereby enacted and ordained by the authority of the same:

SECTION 1. That section 1 of Ordinance no. 3411, passed finally in Council June 7, 1960, entitled, "An Ordinance Establishing the Loop System and Designating Certain Streets as One-Way street, and Providing Penalty for violation", as amended by Ordinance No. 3469, passed finally April 18, 1961 and by Ordinance No. 3518, passed finally April 3, 1962, be and the same is hereby further amended by deleting from the ordinance the following:

BAUMER STREET — One way South from Spruce Street to Teak Street

The purpose of this deletion is to make Baumer Street, between Spruce Street and Teak Street, open for traffic in both directions to address the special needs of commercial and truck traffic flow from commercial and industrial properties

SECTION 2, All the other provisions of the said Ordinance No. 3411, Ordinance No. 3469 and Ordinance No. 3518 are incorporated in this ordinance by reference and enacted as though all the sections thereof had been fully set forth herein.

SECTION 3. This ordinance shall take effect immediately upon its final passage.

SECTION 4. This ordinance shall be known as amendment to "Loop Traffic System Ordinance."


