AN ORDINANCE

AMENDING ORDINANCE NO. 5192, passed finally on December 22, 2015, titled: AN ORDINANCE ESTIMATING THE AMOUNT OF REVENUES TO BE RECEIVED BY THE CITY OF JOHNSTOWN FROM VARIOUS SOURCES AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR SPECIFIC PURPOSES FOR THE OPERATIONS OF THE VARIOUS FUNDS, BUREAUS, DEPARTMENTS, AND THE PAYMENT OF DEBT SERVICE AND PENSION FUND OBLIGATIONS OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, FOR THE CALENDAR YEAR BEGINNING JANUARY 1, 2016, INCLUDING THE FOLLOWING CITY OF JOHNSTOWN FUND SECTIONS, AND THE RESPECTIVE FUNDS "BUDGET EXHIBIT A DETAILS", TO CORRECT ERRORS AND OMISSIONS WITH THE AMENDING AND FINAL PASSAGE OF ORDINANCE NO. 5192 ON DECEMBER 22, 2015:

BE IT ENACTED AND ORDAINED, by the Council of the City of Johnstown, Pennsylvania, and it is hereby enacted and ordained by the authority of the same:

WHEREAS, on November 10, 2015 City Council under Ordinances for First Read placed Bill 25 of 2015 on the calendar, titled AN ORDINANCE ESTIMATING THE AMOUNT OF REVENUES TO BE RECEIVED BY THE CITY OF JOHNSTOWN FROM VARIOUS SOURCES AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR SPECIFIC PURPOSES FOR THE OPERATIONS OF THE VARIOUS FUNDS, BUREAUS, DEPARTMENTS, AND THE PAYMENT OF DEBT SERVICE AND PENSION FUND OBLIGATIONS OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, FOR THE CALENDAR YEAR BEGINNING JANUARY 1, 2016, INCLUDING THE FOLLOWING CITY OF JOHNSTOWN FUND SECTIONS, AND THE RESPECTIVE FUNDS "BUDGET EXHIBIT A DETAILS"

WHEREAS, on December 9, 2015, City Council was presented, for consideration, certain line item amendments to Bill 25 of 2015 by the Director of Finance, and

WHEREAS, on that same date, December 9, 2015 City Council passed finally, Resolution No. 9790, amending Bill 25 of 2015, as proposed on November 10, 2015; and

WHEREAS, the amending of any Ordinance of the City of Johnstown is required to be thru and by Ordinance or motion to amend an Ordinance, the actions taken by the passage of Resolution No. 9790 were improper, and thereby rendered the City of Johnstown's 2016 Operating Budget (Ordinance No. 5192) a non-complaint enactment of the 2016 City of Johnstown Budget, and

WHEREAS, by the final passage of this Ordinance, the errors and omissions taken by City Council on December 9, 2015 and December 22, 2015, are hereby corrected and the 2016 City of Johnstown Budget is now complaint

Section 3. All ordinances or part in conflict herein are in the same are hereby repealed

Section 4. This Ordinance shall become effective retroactive as of January 1, 2016.
